Ronda Ludwig - Branch President

- Called the meeting to order.
- Proposed Notice of Motion to change APOC Pacific Local Constitution (Article 7 Branch Officers) as follows:
 - Grievance Officer Position to be renamed as Grievance Officer Collection and Delivery.
 - o Staffing Grievance Officer Position to be renamed as Grievance Office Plant Operations.
- The proposed change will allow for better representation of membership as the 2 officers will be more familiar with the issues in their areas of knowledge. Sales and Support staff can approach either person in case they need any support.
- Asked for any objection to proposal no one objected to the change.
- Proceed with the change 1st (Dana Leblanc); 2nd (Wicky Wong).
- The remainders Articles of the Constitution will be updated to reflect this change.
- Next week, we are looking at supervisory shortages of 11 in C&D and 21 in Plant. The plan will be to bring those on "projects" back to operations in November to assist with the Peak Operation.
- APOC has asked CPC to conduct Exit Interviews with the supervisors leaving CPC. So far it appears to be that they are leaving because of: non-support, lack of training/onboarding/Plant culture.
- APOC has now updated the logo and it was revealed at the National Convention in June.

Trevor Henderson – Second Vice President PPC

- Onboarding of new supervisors training has slowed as Operations unable to release supervisors for training due to shortages.
- Dana Leblanc:
 - CPC has commissioned at national level to put an onboarding project together for Plants (as in C&D).
 - CPC has recognized the value and need for this type of training. This will be coming out in near future.

David Pino - Grievance Officer

- Delivery Systems Re-Architecture (DSRA) initiative will replace legacy addressing, collections and delivery systems; using PDTs to record and process log sheets and point of call update requests.
 - o On September 30, 2019, a new Point of Call Update Request application will be introduced on the PDT, replacing the current Edit Book process.
 - o All point of call updates made on PDT will immediately flow to a Supervisor's TASK Console.
 - Once the Supervisor has entered the data in AIM and closed the task, the request status will be updated on the PDT. The route details will be updated the Monday after the update was made in AIM.

Trevor Ferris – First Vice President (PPC)

- Moving a supervisor from their substantive position. If you're being moved from your home position, please ensure that you speak up and say no; tell your manager/superintendent that you're in disagreement with it.
- Two grievances have been resolved with the Letter of Expectations being removed from the files.
- EOL (PPC) new process has been finalized and will be in place over the next couple of weeks.
 - PPC will considered as One Office and thus EOL for Operations and Transportation will be combined.
 - o Transportation will be assigned highest opportunity on the list.
 - Superintendents (OP2s and OP3s) to have a separate EOL list they will start with "0" opportunities.
 - PIF will have their own EOL list.
- PIF will also be considered the same Office as PPC. There will no longer be a need to be on a Transfer List to bid for a position at the PIF.

Dan Leblanc – Divisional Vice President (Pacific)

A congratulations to the local for putting forth a motion to amend the National Constitution that was
accepted at the National Convention in June whereby the smaller branches will get a bigger share of
the dues collected in their areas (instead of 25% previously). This change will allow the smaller
branches to send more than one person to Presidents Meetings or National Convention – with the
previous model, this was impossible due to lack of funding.
